## WV Operating Companies: Monongahela Power & Potomac Edison

- Fully integrated utility
  - -~550,000 Customers
    - MP: ~395,000
    - PE: ~155,000
  - Transmission
    - 2,350 miles of lines
  - Distribution
    - 27,629 miles of lines
  - WV Based Generation Assets
    - Fort Martin Power Station
    - Harrison Power Station
    - Solar Sites\*





#### **Generation:** Fort Martin Power Station

- Online: 1967 & 1968
  - Unit 1: 552 nMW
  - Unit 2: 546 nMW
- 2022 Generation 4.95M nMWh
- 2022 Coal Burn ~2.2M Tons
- 2022 Capacity Factor
  - 51.5%
- WV Economic Activity
  - 177 Employees, ~\$10M in taxes
  - \$462M
  - Supports ~1,500 state jobs





#### **Generation: Harrison Power Station**

- Online: 1972, 1973, & 1974
  - Unit 1: 662 nMW
  - Unit 2: 661 nMW
  - Unit 3: 661 nMW
- 2022 Generation 12.06M nMWh
- 2022 Coal Burn ~4.8M Tons
- 2022 Capacity Factor:
  - 69.4%
- WV Economic Activity
  - 225 Employees, ~\$37M in taxes
  - \$874.9M
  - Supports ~3,000 State jobs






### **Major Capital Investments**

- Effluent Limit Guideline (ELG)
  - Compliance project
- \$139M at Ft. Martin and Harrison
  - Ft. Martin: \$89M
    - ~277K Manhours
  - Harrison: \$50M
    - ~151K Manhours
- In-service: 2024 & 2025








#### **Generation:** Other

Target In-service: 12/2023
19MW Capacity
94 acres
~\$16M ITC benefit
~6,000 Piles
~49,000 panels
>100-person crew
