You may pre-register to speak at the meeting or post public comments at www.energy.wv.com/energyplan.

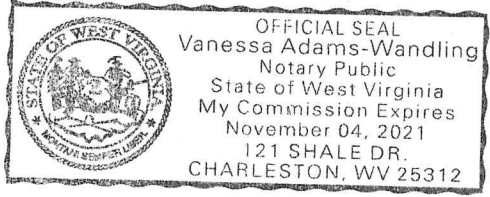
